# LEADING BRITISH GENEALOGIST SUPPORTS G.R.O. "FREE ACCESS"

Campaign launched, politicians to be contacted and challenged, arguments sharpened all to one end - greater access, free of charge, to the records of the Registrar General for England and Wales. Whilst, the Irish debate on the GRO was fraught with difficulty as the various genealogical organisations found it hard to achieve a united front on the threatened price increase in Dublin, the leading British genealogist, Anthony J. Camp has openly called for easier and cheaper access to older civil registration records in England and Wales. In this month's issue of Family Tree Magazine he argues strongly for the microfilms of the records of Births, Marriages and Deaths from 1837 (England & Wales) to be made available free of charge to family historians. Odd to think that a similar proposal from this Society found little support at CIGO meetings, though, this Society's approach is exactly what Mr. Camp seems to be advocating for England and Wales. He has called on family historians to write to each member of the British Parliament. The aim of the campaign initiated by the article is to make "Historic" registration records, defined as those older than 75 years, open to public scrutiny by microfilm copies throughout the UK. Indeed, this Society's proposal for Ireland suggested that records over 70 years be microfilmed and placed in the National Library or the National Archives. The Society wishes Mr.Camp and Michael Armstrong every success with the British campaign and earnestly hopes that their example will enlighten and encourage genealogists and their organisations in Ireland to take a similar stance on behalf of the public's right of access to their "genealogical heritage".
