#### MINISTER PUBLISH REPORT

The Minister for Arts, Culture, Islands & The Gaeltacht, Ms. Sile de Valera TD, is finally to receive the "Report on Genealogical Practises in Ireland" prepared by the Heritage Council. It is reported that the Council will deliver the document during this month and that the Minister will view it before deciding when to publish it as promised earlier this year. The Society made several submissions to the Heritage Council and we eagerly await its publication and the recommendations of the Council. Understanding the varied and sometimes conflicting interest groups involved in genealogy in Ireland, this report should make very interesting reading. However, any failure by the Heritage Council, in this report, to comprehensively and decisively tackle the problems associated with the public accessibility of records and the future of the Irish Genealogical Project (Heritage Centres) will certainly call into question its ability to deal with genealogy at all. The report was commissioned by the previous Minister, Mr. Michael D. Higgins, TD following the debate on The National Cultural Institutions Act, 1997. We await the early publication of the report - as promised by the Minister Sile de Valera, TD...

#### STRATEGIC POLICY COMMITTEES

These SPCs will comprise of elected County Councillors and sectoral representatives to assist, advise and participate in policy formulation at County Council level in accordance with a new Government initiative aimed at improving local government. Of the six nominees, five belong to organisations represented on An Foram Oidhreachta - Dun Laoghaire Rathdown Heritage Forum, of which, this Society is a member and co-founder.

#### CIGO SEEKS DLGS RETURN

The Executive Committee is to consider the request from CIGO to overturn the Society's decision to withdraw our delegates to CIGO until that organisation's AGM in November. However, it is unlikely that the Executive Committee will make that decision before the Society's Annual General Meeting in October where the membership may be invited to debate the Society's continued membership of the Council of Irish Genealogical Organisations. Currently, this Society is committed by its Constitution to membership of CIGO and the international Federation of Family History Societies, however, any future arrangement with CIGO may well depend on the will of our members as expressed at the October AGM and attitudes towards the Heritage Council's Report on Genealogy.

# IRISH GENEALOGICAL SOURCES NO. 7 DUBLIN STREET INDEX 1798 extracted from WHITELAW'S CENSUS

Sean Magee, in his second volume in the Irish Genealogical Sources Series, provides an excellent research aide to family and social historians with an interest in Dublin City at the end of the eighteenth century. This index is taken from a census conducted by the Rev. James Whitelaw and contained in the appendix to the "History of the City of Dublin" by Whitelaw, Werburton & Walsh - published in 1815. Though the census itself has, unfortunately, not survived this index is a fascinating source. This is a valuable reference book as many of the street names are no longer in use today and therefore, may have been difficult to locate - Sean has made the task of cross referencing street and parish much easier. This index enables the researcher to identify the parish in each case for the year of The Great Rebellion of 1798 and just before the Act of Union of Great Britain and Ireland in 1801.
