At the end of an era and looking forward to the first year of the 21st century, many Irish genealogists will be hoping for great improvements in the accessibility to our genealogical heritage provided by the State and other agencies. Indeed, over the past few years, vigorous campaigns have achieved minimal success, however, this can not be attributed to any lack of commitment by anyone involved. The perennial problems that have assailed the smooth development of genealogical services in Ireland are many and varied. These problems have become acute of late due to the lack of a coherent and comprehensive vision of what must be achieved to meet the standards prevailing in other countries, however, this may have more to do with Ireland's centralised administrative culture than any other reason. Indeed, in order to be in a position to propose a remedy to this situation, Mr. Michael D. Higgins, T.D., as the Minister for Arts, Culture & the Gaeltacht in 1996, called for a comprehensive report on genealogy and the provision of genealogical services in Ireland to be compiled by the Heritage Council. Unfortunately, such as report has not been compiled as yet. In Ireland, the State is both the main custodian of genealogical records and the controller, through either funding or employment schemes, of other genealogical service providers like the Heritage Centres and indirectly, the Public Library Service. These State services, under many different Government Departments, were not set up with the provision of access to genealogy as their primary functions. There is, therefore, no co-ordinated view on the provision of genealogical services or the protection, conservation and acquisition genealogical material, or indeed, the promotion of an awareness, appreciation and knowledge of our genealogical heritage. The provision of a generally acceptable definition of that heritage has

caused needless difficulty with some sectors preventing a full adoption by all of the "Principle of Public Ownership and Right of Access" to our genealogical heritage. If there is anything that unites all those involved in Irish genealogy it is frustration and an over exhausted patience with endless half-measures and excuses. Indeed, in an overtly conciliatory address to his AGM, the out-going Chairman of CIGO, acknowledged the commitment of all involved in Irish genealogy to the resolution of these problems, especially the widest possible access to the GRO records. The GSI shares his view and calls on all concerned to consider a global approach to the development of Irish genealogy and heraldry in the 21<sup>st</sup> century. Possibly, this may be arrived at through the provision of a "manifesto" agreed between CIGO and representatives of the three largest organisations in Ireland, North of Ireland FHS, Irish FHS and the Genealogical Society of Ireland, all of which are not members of CIGO. The areas that could be discussed are accessibility, official coordination, accountability, legislative measures, standards, education and State promotion of genealogy and heraldry. Could it be that Irish genealogy in the 21st century may not have one voice, but at the very least, we'll all be able to sing from the same hymn sheet on agreed issues of mutual concern? Only time will tell.

#### **NEW PUBLICATION**

1901 CENSUS INDEX. Work started on the transcription of the Census Returns for the Greater Dún Laoghaire area back in 1992, however, few of our Members were computer literate at that time and indexing the Census took longer than envisaged. But now with over 70% of our Members owning their own computers, and others with access to computers, matters progressed quickly to the publication of the first volume. The original transcription was undertaken by a number of members from the Census Returns under the direction of Tony Daly, FGSI and computerised by Marie Keogh. Then each entry was checked by Annette McDonnell. The Greater Dún Laoghaire area includes what was then the Kingstown, Blackrock, Dalkey and Killiney/Ballybrack Urban District Council areas of south County Dublin from the City boundary southward. The first volume covers the Blackrock UDC area and contains the names, addresses, ages and areas of birth for over 4,500 people being the heads of households, visitors and lodgers in the area. Work is progressing on the next volumes to be published in the New Year to commemorate the 100<sup>th</sup> anniversary of the taking of this Census on March 31<sup>st</sup> 1901.

# **NORTHERN NEWS**

GSI Northern Ireland Representative, Mr. James Davidson, has reviewed a copy of the latest edition (Vol. 1 No. 3) of "Due North" - The Magazine of the Federation of Ulster Local Studies and says there's much more in this glossy publication than meets the eye. Local history publications can and do provide fascinating pieces of information for family historians and "Due North" is no exception. Whether, you have roots in Ulster or not, you're bound to find something to whet your appetite here with articles on the Railways, Archaeology, Belfast's Civic Archive and of course, the "Titanic". The fallen of the Great War (1914-18) and the last War are brought to mind by Robert Thompson in his article "Discovering Ballymoney Heroes" - over 300 men who lost their lives in battle from the Ballymoney district of County Antrim. This list includes five described as either from the "Canadian" or "American" forces. Gráinne Dooher provides a fascinating account on the Reports of the Magistrates on lawlessness in County Tyrone during the famine years. Most of these disturbances centred on famine relief work in the district. There are also many reviews of local history publications from Ulster, including the very useful book by Jonathan Bardon "A Guide to the Local History Sources in the Public Records Office of Northern Ireland" ISBN 0 85640671 6" published by Blackstaff Press, Belfast - Price Stg£9.99. The Minister for Health & Children, Mr. Mícheál Martin, T.D., said on the 7<sup>th</sup> October in Dáil Éireann "It is planned to publish a consultation document in December 2000 on the future development of the registration service and to obtain the views of all interested parties."
